IF YES: Please describe what legal recognition it has and indicate the place of legal incorporation or registration: Our organization was created on June 4, 2013, registered on November 14, 2014 with the Register of associations and approved by

the Chadian State on October 26, 2015 in File no. 4668 (authorization to operate of the Department of territorial administration and decentralization).

d. Describe your organization's structure (e.g. governing and decision-making bodies and processes): ACIEDD is divided into the following bodies: The General Assembly (AG) and the Executive Board (BE). The association is governed by the Executive Board, composed of members elected for a year by the General Assembly after a call for candidates. The Executive Board is vested with the broadest powers to act on behalf of the association and to undertake or authorize all actions and operations allowed of the association which are not reserved to the General Assembly of members. The Executive Board may ask the General Assembly for information or consult with it at any time. The regular General Assembly includes all active members having paid their contribution. It meets at least once a year. The Chairperson, assisted by the members of the Executive Board, chairs the Assembly and presents the moral situation of the association (reports on its past and upcoming activities.) The General Assembly adopts the annual budget and approves the accounts of the previous year presented by the Treasurer.

: Several professional fields coexist within our organization, including computer scientists, students, civil servants, engineers, entrepreneurs, and individual users.

The organization has a mailing list where all members are included. This allows them to receive all the documents and information regarding the organization's activities. It also has a Whatsapp group that allows all members to discuss past and upcoming activities. All members of the organization are grouped in coordination groups (of which there are four; for example, the coordination group on the ecological and digital economies, the coordination group for humanitarian support, etc.) Some information is shared via SMS or Via our through our Facebook group and page.

The members of our organization are volunteers from several sectors, including computer scientists (18%), higher level students (25%), civil servants (15%), engineers (7%), students (10%), entrepreneurs (17%), consumers (5%), and others (3%).
