I was saddened and disappointed by the necessity to resign, and the GNSO Council, specifically the Chair and Vice Chairs were to say the least 'unimpressed', but we were all grateful that the excellently qualified and capable Olivier Crepin LeBlond was able to when I asked if he would, offer himself as my replacement to the ALAC for their consideration and of course then appointment.

At the time I expressly stated that it was my firm wish to return to the GNSO as the ALAC Liaison, at a future time if this was at all possible. and supported by the ALAC. I most sincerely hope that the Selection Committee will see fit to propose me as the ALAC Liaison to the GNSO and that the ALAC in turn will consider my 'return to the role' a timely and appropriate one.
