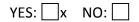

An informal co-operation exists with another internet expert, Attorney Dr. Wolfram Proksch, .WIEN registry, ...AT registry, Internet Service Providers Association in Austria and the Austrian Internet Governance Forum, managed by the Federal Chancellery. The WZRI has already organised workshops on the work of ICANN, in particular related to the ongoing topics in ICANN Meetings."
