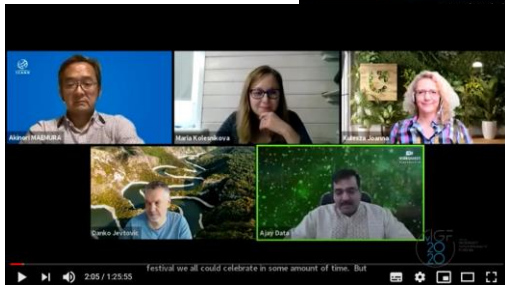

**The fifth Eastern European Domain Name System Forum (EEDNSF)** has taken place online from 18-19 November 2020. The event is organized by the Internet Corporation for Assigned Names and Numbers (ICANN) in partnership with Caucasus Online, which is hosting the event.

The EEDNSF is part of ICANN's regional outreach efforts to raise awareness about DNS-related issues; and collaborate with stakeholders through discussions on topics currently under development. The Forum will bring together interested parties and experts to share experiences, and update participants on regional and global domain industry trends. This year's program included the following key topics:

- **Regional focus on Internationalized Domain Names (IDNs) and Universal Acceptance (UA)**
- **ICANN's Identifier Technology Health Indicators (ITHI) and Health of the DNS Ecosystem**
  - **DNS Operations and Security**
  - **Business Continuity for Registries: A Regional Approach**

The EEDNSF gives participants an opportunity to interact with one another and discuss the many business, technical, and policy aspects of the domain industry. Maarten Botterman, ICANN Board Chair, and Danko Jevtović, Board member, were attend along with leading regional and global experts in the DNS industry.

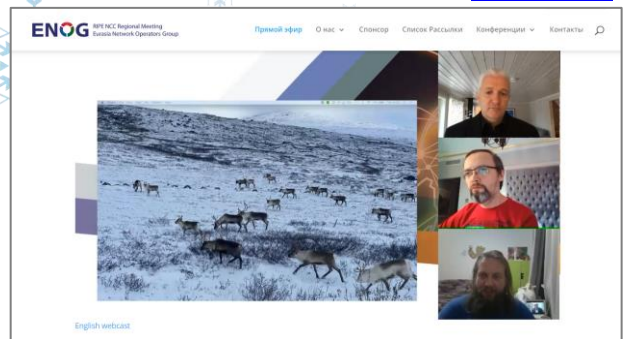




### ENOG 17 / RIPE NCC

Regional Meeting was a virtual meeting and took place from 9–13 November 2020

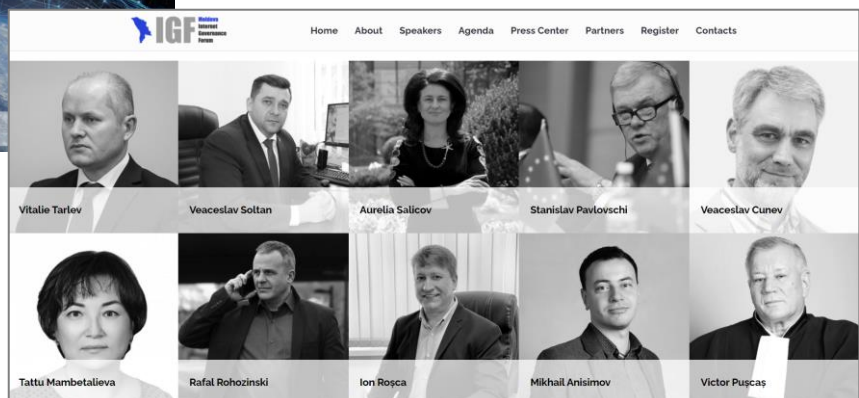

ENOG (Eurasian group of network operators) is a forum where technology experts from Eastern Europe, the Caucasus and Central Asia gather to discuss the key operational issues and share ideas on Internet development in the region. Discussions at ENOG traditionally revolve around networking and cooperation between operators in the region. Topics cover issues, tools, experiences, and best practices in areas such as IPv6, DNS, peering, routing, security, and more.

On November 23-24, 2020 the first national IGF (**Moldova Internet Governance Forum – MIGF 2020**) was held in Chisinau. Moldova became the 88th country to launch the IGF initiative.

Donuts and Afilias announced today that Donuts is acquiring Afilias in a deal that is expected to close in December 2020 for an undisclosed amount. The combined entities will support over 25 million domain names spanning well over 400 TLDs. The deal will not include certain Afilias businesses, such as the mobile software and registrar businesses, which will remain with Afilias' original group of investors.
