

## **Terms and Conditions**

### **1. INTRODUCTION**

These Terms and Conditions shall govern ICANN's Trivia Contest entitled "How much you know about ICANN" which is organized by ICANN's LAC GSE for the LACRALO community. The Trivia Contest will be a skill-based event, with the winner being the individual that answers the most correct questions.

The Trivia Contest will be held during the Contest Period as set out in these terms.

The Organizer reserves the right to vary, postpone or re-schedule the dates of the Contest or extend the Contest Period at its sole discretion.

### **2. CONTEST MECHANISM**

Eligible Contestants may access the Trivia Contest by login to Facebook at [https://www.facebook.com/pages/LACRALO-Trivia-Contest/921865357880127?sk=app\\_351082565089532](https://www.facebook.com/pages/LACRALO-Trivia-Contest/921865357880127?sk=app_351082565089532) accept the Trivia Contest Terms and Conditions before playing the Trivia Contest.

Once the Contestant clicks on the start button, he or she will have 240 seconds to answers the most questions.

### **3. ELIGIBILITY**

The Trivia Contest is open to all LACRALO community members.

Contestants must be citizens of Latin America or Caribbean Islands and must be 18 years old or above at the time of entry.

### **4. INELIGIBILITY**

ICANN employees are not allowed to participate in the Trivia Contest. ICANN reserves the right to disqualify any contestant it deems has an

unreasonably unfair advantage due to some contractual relationship with ICANN.

## **5. TRIVIA CONTEST PERIOD**

The Contest will be held beginning 20:00 UTC 14 May 2015 and ending 22 May 2015 at 23:00 UTC.

## **6. LANGUAGE**

The Trivia Contest will be conducted in Spanish and English.

## **7. WINNER**

The winner of the Trivia Contest will be the person who answers to most correct questions.

In the event of a tie, two prizes will not be awarded. A tie will be broken by random drawing from among the tied, qualified entries. The drawing will be conducted by ICANN, and the results of the drawing are final.

The winner will be announced May 26, 2015. If the winner does not claim the prize, the contestant with the next highest number of correct answers will be selected, or, if the winner was chosen by a random drawing where there was a tie, to the other individual, or, if multiple individuals, by another random drawing.

## **8. PRIZE**

A round trip to the ICANN 53 meeting in Buenos Aires that will take place from June 21 to June 25.

Coach class airfare (dates to be determined by ICANN, but flexible as reasonably necessary to accommodate Winners schedule) and hotel accommodation for 6 days and 5 nights standard to be arranged by ICANN. All other costs and expenses are the responsibility of the winner.

## **9. Legal Terms**

The winners must sign a release to claim the prize and to agree to allow ICANN to use their name, and/or likeness for promotional purposes without further compensation.

Winner may not request substitution or other consideration of the prize specified and the prize is non-transferable and has no cash value, expressed or implied.

A 1099 MISC form will be completed and filed with the internal revenue service for the winner. All local, state and federal taxes are the sole responsibility of the winner.

By participating in the trivia contest, each entrant agrees to release and hold harmless ICANN and Facebook, and their respective agencies, affiliates, sponsors, or representatives from any and all losses, damages, rights, claims, and actions of any kind in connection with the trivia contest or resulting from acceptance, possession, or use of any prize, including, without limitation, personal injuries, death, and property damage, and claims based on any libel, slander, illegal competition or trade practice, violation of rights of privacy, infringement of copyrights or other rights of third parties.

This trivia contest is in no way sponsored, endorsed or administered by, or associated with, Facebook.

Unless otherwise stated, multiple entries by the same person will be discarded and may be deemed cause for disqualification.

ICANN is not responsible for any technical problems occurring with any trivia contest submission that either inhibits or increases the chances of winning.

In the event of a tie, two prizes will not be awarded. A tie will be broken by random drawing from among the tied, qualified entries. the drawing will be conducted by ICANN, and the results of the drawing are final.

With respect to any disputes regarding the trivia contest, the decision of ICANN is final.
