## Messages

### From APRALO Chair Satish Babu



Dear APRALO Community,

Greetings! On behalf of the Leadership Team, I hope you are keeping fine.

In two week's time at the time of writing this message, the ICANN community will host a hybrid-mode meeting of the ICANN74 Policy Forum at The Hague, Netherlands. This is the first time in the last two years that community members are coming together face-to-face, albeit under strict social distancing and other pandemic-related restrictions. Yet, it is an important step towards returning to our earlier cadence of meetings.

During ICANN74, the At-Large community members will hold 10 sessions. The sessions will include two At-Large priority sessions, two joint sessions, four RALO sessions, and At-Large welcome and a wrap-up sessions. The first session priority session is "Evolving the DNS Abuse Conversation: An End User Perspective.", where we will explore end-user perspectives on the mitigation of DNS abuse. The second priority session is "Closed Generics: Finding a Better Balance". ALAC will also hold joint sessions with SSAC and GAC.

We also need to start planning for ICANN75, which is currently scheduled as a hybrid meeting at Kuala Lumpur, Malaysia, which would be in our region. It is also notable that there are a number of events before and after the ICANN75 AGM: APNIC 54, the joint APRI GF-APSIG meeting and the India School on Internet Governance. The next few months will certainly be busy for us.

We conducted our leadership elections this month. I would like to congratulate all the winners and would like to commend everyone who contested or voted. Although the newcomers would assume charge only after ICANN75, this is a good time for onboarding them.

## Monthly Call Updates

### ALAC Call

The ALAC calls both in [April](#) and [May](#) had updates presented by ICANN Board Vice Chair Leon Sanchez on the board activities, updates on ALAC policy development activities; updates from the ALAC leaders and liaisons and discussions on the At Large activities and preparations for ICANN74.

At the April call there was a panel discussion on the At Large Policy which was moderated by Olivier Crépin-Leblond. The topics discussed were the ALAC's responses to the questions from the GNSO Small Group on DNS Abuse by Alan Greenberg and Jonathan Zuck and on the IGO Final Report by Yrjö Länsipuro and Justine Chew. Besides there was an update provided on the 2022 ALAC and RALO Elections.

Additionally, during the May call, guest speaker Graeme Bunton provided an update on the DNS Abuse Institute Activities; a presentation and discussion on the proposed changes in the ALAC Rules of Procedures (ROP) by Alan Greenberg

- a UA Training session in Hyderabad, India in September 2022, in collaboration with several Indian ISOC Chapters, inSIG 2022 and ICANN GSE

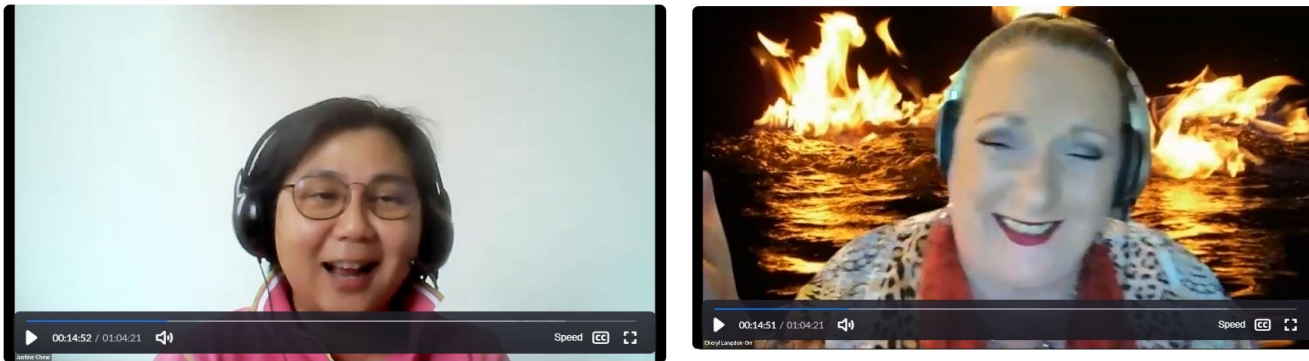

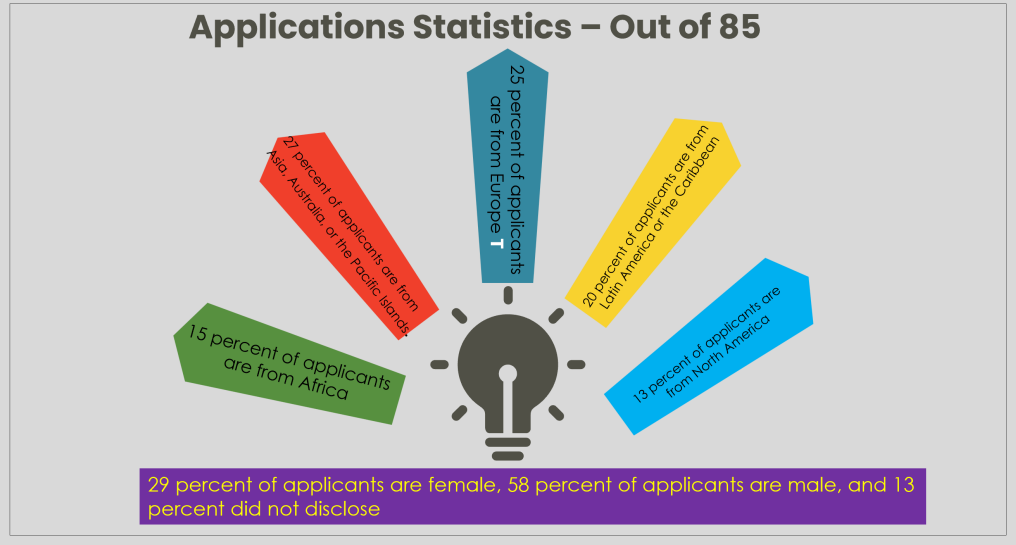

### Operations Finance and Budget Working Group Update

The work of the OFB WG follows the annual cycle of ICANN Planning, starting in May-June with the Operating Initiatives, followed by the development of the IANA Operating Plan and Budget in late July-August and then in September-October working on the ICANN Operating Plan and Budget based on the ICANN Planning cycle.

The OFB WG recently reviewed the outcomes of the ALAC/RALO Chairs Strategic Trends workshop. The workshop, run by ICANN planning, asked the participants to contribute their own views of ALAC priorities under six headings: Security, ICANN governance, Unique Identifiers, Geopolitics, Financials and Trends. Some of the hot topics for the participants included several aspects of DNS Abuse, issues surrounding attracting and assisting new members to ALAC, and impacts of global issues on ICANN. The outcomes from the workshop will inform the ALAC responses to Operating Initiatives in the ICANN budget.

## Update from Our ALSes

### Conference in Armenia | Girls in ICT 2022: Access and Safety

Internet Society NGO jointly with Internet Society Armenia Chapter organized a Conference Girls in ICT 2022: Access and Safety on April 28, 2022.

In line with the objective of the international Girls in ICT Day, the Armenian Conference aimed to engage and support women in ICT and encourage young participants to pursue STEM education and career.

The Conference started with the overview and trends of women's involvement in the field of information and communication technologies in Armenia and in the world. It continued with talks on dangers commonly encountered on the Internet, such as various scams, theft of personal data, digital safety issues, etc., as well as opportunities and methods to avoid such situations and to stay safe online. The Conference concluded with talks about STEM innovative educational programs developed by Synopsys Armenia for high school students and about the Armenian School on Internet Governance, an initiative run by the Internet Society NGO and the Internet Society Armenia Chapter.

Over 70 teachers, parents and young participants joined the Conference in-person and around 30 participants joined online and had dynamic and active discussions.
