We hope that we will be able to invite faces, cases and examples of solutions to problems with UA in ICANN EUROPEAN region and take part in the event.

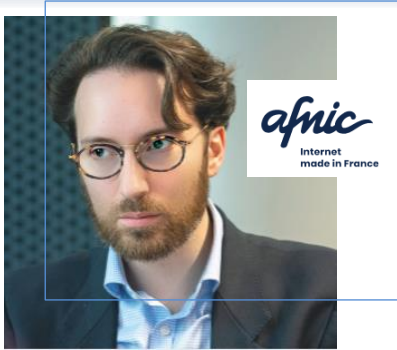

French Internet Governance Forum (IGF France)

“The 2022 edition of the French Internet Governance Forum (IGF France) was successfully held on Monday 5 December 2022 in Paris and remotely. As the annual rendez-vous of the French Internet ecosystem, the Forum brought together actors from the public and private sectors, civil society, the technical community and the academic world in Paris and remotely, for the first time since 2020, to exchange views on the much discussed subjects of the future of internet governance and of an internet that is still a work in progress.

The much-discussed subject of Internet governance.

Following on from the [17th Internet Governance Forum](#), which came to an end on Friday, 2 December in Addis Ababa, Ethiopia, the French Forum illustrated the pertinence of facilitating exchanges on Internet governance at national level and of **initiating collaboration and meetings to construct the Internet of tomorrow.**

This edition of IGF France produced a wealth of debates and encounters. A plenary session on the future of digital governance, which I had the pleasure of mediating together with Jessica Galissaire of Renaissance Numérique, brought together Benoît Loutrel of ARCOM, the French regulatory authority for audiovisual and digital communication, Henri Verdier, France’s ambassador for digital affairs, Tawfik Jelassi of UNESCO, Maryse Artiguelong of the Human Rights League of France, Gilles Brégant of the ANFR (French national spectrum agency) and Thomas Dautieu of the CNIL (National Data Protection Agency) and put **into perspective not the future scenario but the several possible future scenarios of digital governance**; or perhaps it would be more accurate to say the governance of the various possible future digital scenarios.

This look at alternative futures was made possible by four workshops:

- One on training and the responsible use of digital resources;
- One on interconnection and Internet neutrality;
- Followed in the afternoon by one on the future of digital regulation in Europe. “Towards open regulation?”
- And lastly, one on Internet fragmentation.

In short, the **need to talk about the digital future in the plural** and to make sure the Internet forms part of a future that is desirable, from data to constellations of satellites, and the user’s place in these governance systems.

An Internet still under construction?

The Internet has not yet been completed, nor is what has been achieved set in stone. When it comes to digital interdependence, it is just as important to put the Internet into perspective as it is to envisage the 'mise en abyme' effects of the future.

Now that we are just months away from the 20-year review of the World Summit on the Information Society (WSIS), we have to **ask questions about the Internet of today and favour a dynamic and demanding ecosystem that will be capable of responding to the challenges posed by the Internet of tomorrow.**

It is for this reason that the 2022 edition of the French Forum chose to surround itself with **Les arts d'à côté** (next-door art). An exhibition of more than twenty original works created for the occasion, workshops, drawings by the artist Placide, all designed to **reflect and represent the Internet in a different way.**

The closing plenary session of this edition was in four parts. First of all, feedback on the four workshops by the M2 Master's in Law of Digital Activities students of the University Sorbonne Paris Nord co-directed by Guilhem Julia and Anne Cammilleri, followed by an address by Axelle Lemaire (Red Cross), who was Secretary of State for Digital Affairs and Innovation from 2014 to 2017, who talked of the importance of innovation for the digital transformation but also of the need for simplicity and frugality.

Prior to the closure there was a round-table on "Environment: towards a new digital agenda?" involving Serge Abiteboul (Arcep, the post, telecommunications and media regulator), Véronique Torner (Alter Way and Numeum), Gilles Babinet (National Digital Council), Pierre Bonis (Afnic) and Nicolas Chagny (Internet Society France and WebForce3). The discussion, mediated by Sébastien Bachollet of EURALO, and Nathalie Bouarour (CNNum) stressed the importance of multi-discipline skills in understanding the different facets of the digital and ecological transitions, and the need for data in order to understand the environmental cost of digital products over their whole life cycle. While digital products certainly represent an environmental cost, digital technology also contributes to their reduction.

The final word came from Jean-Noël Barrot, Minister for Digital Transition and Telecommunications. We thank the speakers, the moderators and the rapporteurs for the quality of their contributions and the technical teams and the Forum organisation committee who worked in the multi-stakeholder spirit of the WSIS. Well done!"

Cyber Governance Dialogues (CGD) By Pari Esfandiari, President Global TechnoPolitics Forum



Cyber governance is a challenge facing policymakers around the world. It is a new, complex, and evolving discipline that deals with a wide range of interrelated, overlapping, and even conflicting issues with local and global implications often at odds. The key concern is the lack of stakeholders' knowledge and expertise required to comprehend, let alone, offer policies that capture the complexity of this dynamic context.

The CGD series was launched by the Global TechnoPolitics Forum (GTPF). It aims to overcome the current knowledge gap while expanding the dialogue. The objective is to broaden the scope of the dialogue, offer opportunities to share knowledge, and create trust and peer-to-peer intimacy among participants as they developed a shared diagnosis of problems and a common analytical framework in this small, intimate convening. This objective is achieved by offering bespoke, informative, and interactive dialogue sessions that provide a comprehensive understanding of key global cyber governance issues and their local interpretations, implementations, and implications. The sessions are designed and executed by the GTPF, in collaboration with leading local institutions, utilizing in-house expertise, global thought leaders, and local intelligentsia.

Dialogue with South Korea was the first webinar of this series that was launched in collaboration with Korea Internet Governance Alliances (Kiga) and the Pacific Century Institute (PCI). ICANN community's support was critical. The seminar brought together thought leaders and experts in the field from the U.S. (2), Europe (2), and South Korea (5), who offered seven presentations and three-panel discussions. The program was offered in three parts, each part was followed by a round table discussion.

- Part I: **Wolfgang Kleinwächter** and **Olivier Crepin-Leblond**, Moderated by **Gregory Treverton** and **Pari Esfandiari**. The session offered a historical background on the evolution of global Internet governance, institutions involved, and discussed the geopolitical implications as well as the complexity of the system. - Part II: Panelists: **Dongman Lee** and **Boknam Yun**, moderated by **Pari Esfandiari**. This session explained the development of the Internet and its governance in South Korea. See the Webinar here: <https://youtu.be/NCoEzDxpbAQ>
- Part III: Panelists - **Greg Treverton**, **Pari Esfandiari**, **EungJun Jeon** - Moderated by **Jiyoun Choe** and **KS Park**. The session discussed the instruments of governance and geopolitics. 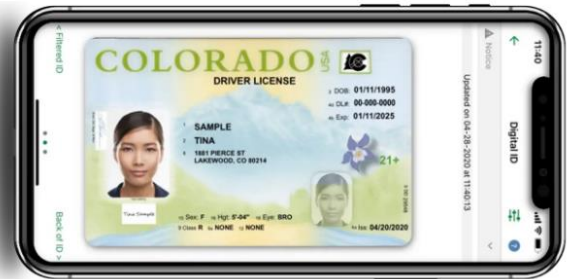
So, are we ready for a full transition to digital IDs?

At the beginning of September 2021, Apple announced that the first eight states in the U.S. were signing up to include driving licences and state IDs in Apple Wallet and Apple Watch. The aim of this move is to provide people with an easier, faster and more secure way to present their driving licence or state ID. Imagine being able to travel without your passport and sailing through security checkpoints and lanes at the airport using just your iPhone. This may seem an unrealistic prospect for some, but it is beginning to look as if we may be able to experience a scenario like this in the near future.

At this early stage we see both the private and public sector trying to come up with separate digital ID solutions. The European Commission wants to develop an app that would contain the digital version of an ID card. It seems clear that the EU wants to **retain control of its citizens' data, rather than share it with tech giants situated outside the EU.** Apple is doing the same.

“It’s all about the market”, says Yuliya Morenets, the founder of the Youth IGF. “Apple is a private company seeking to manage data flows. The company has an opportunity to gain the power to manage the storage of national IDs and has no intention of passing it on to governments”. In addition, by presenting such a service, Apple is likely to attract more customers by offering them their products.

It is also important to consider the need for a dedicated infrastructure for the storage of sensitive personal data, such as national IDs and driving licences, information which may also be complemented by other data in the future. The question is who will be the first to build it. Apparently, Apple is in the driving seat here, since it does not have to go through the complex process that governments undergo. **And what if a country does not have funds to invest in such an infrastructure?** It seems to open up more possibilities for Apple to offer their technologies right away.

Sergey from Russia stressed one of the positive aspects. He mentioned that the roll-out of a new feature allowing users to add their driving licence and state IDs to Apple Wallet and Apple Watch would make a life a lot easier for them. Yuliya Morenets thinks **people should be given the right to choose. What if they simply want to use an iPhone to prove their identity, and not the services that government would offer instead,** she asks. And then there is the issue of compatibility as well. If a government provides its own digital ID, will it be supported by Apple devices?

Julie Ward, a former Member of the European Parliament, draws attention to the connectivity problems that might impede the successful implementation and use of digital IDs. She is worried by the fact that the lack of the right equipment or a simple system shutdown could leave people without access to personal data stored on their devices. The digital divide still remains the biggest obstacle for the deployment of e-identity, regardless of whether it is developed by a government or a private company.

“I’m a paper person”, says Julie, adding that people have a tendency to lose their phones.

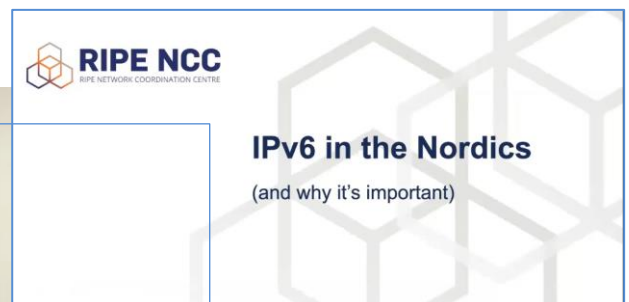

- **One member of the Country Code Names Supporting Organization Council**

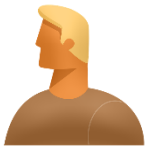
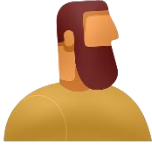
