Re: 2023-05-08 LACRALO Call Meet the Candidates

As I brought up a point of order to the Chair during the meeting in reference, I am currently LACRALO delegate at NomCom and eligible for reappointment for the upcoming term. Therefore I had asked if I was also required to be present at the Meeting with the Candidates as I see my name is not in the Agenda for the Call for the Meeting. I was told that a conversation with the LACRALO authorities would follow after the meeting due to time constraints.

As I still maintain my expression of interest in being eligible for reappointment to continue being a delegate to NomCom, I made during my intervention reference to my documents already in the website. These documents are the SOI¹ and EOI² already submitted.

At the end of the call the ICANN staffer for the meeting stated that there were “Sole Candidates” for 3 position that said posts would be proclaimed according to Article 23 of the LACRALO Rules of Procedure as winners by acclamation (in the Spanish channel “ganadores por aclamación”) without the need of a vote declaring them as such.

I believe that the term is inaccurate with regards as to the delegate to NomCom, as the proceeding withing LACRALO results in a recommendation rather than a winner. Please take note that Article 22 of the Operating Principles of 2018³ are applicable to the NomCom delegate procedure. Section 23 of the LACRALO Rules of Procedure of 2020⁴ only refer to rotation principle applicable for said recommendation.
